Scope: In launching a new academic journal focusing on conflict transformation in Africa in 1999, the African Centre for the Constructive Resolution of Disputes (ACCORD) fulfilled a long-held ambition to contribute to the intellectual development of thinking, writing and dialogue in the field of conflict management on the African continent. AJCR publishes the writings of a wide range of African and international authors in the field, but emphasis has deliberately been kept on profiling the writings of African writers, and the thinking emerging from African universities, colleges and organisations. Articles in the journal are longer and more in-depth than those found in ACCORD's Conflict Trends Magazine, and are of an overtly academic nature. However, readership is not limited to audiences in academic institutions, and the literary style has deliberately been kept accessible and straightforward.

The *Political Bulletin* opens with a lead article and is then divided into five sections, with countries and regional entities listed alphabetically within each.

Continental Alignments: Detailed reports of annual conferences of continental and regional organisations, updates of meetings of regional blocs. Relations between African states.

Internal Developments: Changes of government ministers and constitutional amendments are noted. Elections are covered, with biographies of leading figures and comment and analysis of parties standing.

National Security: Security issues throughout Africa are updated monthly. Reports and analysis consider the implications for the country and region and these are supported by maps and background history.

Military: Defence, arms agreements and cooperation. New Chiefs of Staff, country statistics. The role of the UN and of mercenaries.

Overseas Relations: Diplomatic overtures, changes, sanctions and international meetings, such as Commonwealth, which include Africa. Also changes of government or presidency abroad, which may have a profound effect on Africa.

Social and Cultural: Overviews of a specific topic. Subjects covered include: media, health, education, archaeology, conservation, sport, film, street children.

This in turn hampers the ability to build on past research and record best practices, negatively impacting on the evolution of the field. Innovation in rethinking the paradigm of transitional justice is stifled because there are few settings where cross-disciplinary discourse can take place.

The *International Journal of Transitional Justice* aims to provide just such a forum for developing and sharing knowledge and for building and consolidating research expertise in this vital field of study. Most importantly, IJTJ serves as both a vehicle for this information and as a point of dialogue between activists, practitioners and academics. This dialogue is promoted by the format and structure of the journal. In addition to regular length articles, the journal has a section entitled 'Notes from the Field' which carries shorter practitioner focused articles, interviews, discussion papers, responses to earlier articles, practitioners' reflections, creative writing and the presentation of new data.

'Transitional justice' is defined broadly so as to engage with a wide spectrum of civil society and government initiatives. This is of particular importance as the field itself continues to grow and evolve in concept and scope.

While truth seeking is perhaps the most commonly known instrument of transitional justice today and an increasingly regularized, if contested, element of the democratic transition of many states, countries are also choosing to employ locally inspired forums of justice. Internationally, prosecutorial responses to organized violence have similarly evolved in the past decade. Some of these developments include the advent of the International Criminal Court, the international tribunals in the Former Yugoslavia and Rwanda, the Special Court in Sierra Leone, and increasing acceptance of universal jurisdiction for international crimes.

Bearing in mind these new developments, IJTJ seeks to be flexible enough to respond to dynamic growth in the field as well as to solicit articles from a

Political ideologies are indispensable to appreciating the role of political thought within social, temporal and spatial contexts, both at conscious and unconscious levels. If we move into a cognate discipline, such as International Relations, we find that the area is divided between those who consider power purely in terms of material resources and those who

argue that it is defined by ideas and perceptions - so-called realists' and idealists'. A similar division is found in political-sociology, where some focus upon power in terms of legitimacy and authority while other, more 'hard-headed' theorists view it in Machivallian terms of war and deceit.

- In political philosophy, the key division lies between those who consider power as defined by its exercise, its effects, intentions, and potentialities. In rational choice theory power is divided between those who view it positionally, almost as a kind of luck, and those who see it as episodic.
- In anthropology, in contrast to all the above, power is theorized in terms of rituals and ceremony.
- In sociology, there is a clear division between those influenced by Marxism, who define power in terms of class or economy, and the followers of the tradition of Weber, who consider power as linked to authority and domination.
- In feminist literature, the debate is dominated by the intricacies of the division between social constructivist accounts of gender and those who emphasize violence and material resources.
- Running through all these debates is the fundamental contrast between those who view power negatively, as domination, and those who think of it positively, as an essential ingredient of autonomy and empowerment. In short, some of the key debates within the social sciences are centred on the theme of power and it is intended that this journal should reflect this.

Aside from theoretical debates, the *Journal of Political Power* is a primary outlet for those doing empirical work on relations of power and powerlessness. For instance, the Journal welcomes empirical analysis of the process whereby globalization, ethnicity, nationalism, war and gender are central to the constitution of power, whether conceptualised as domination or empowerment.
