About: The rapid spread of the novel coronavirus and COVID-19 has caused a global pandemic. From China to Italy and the United States, many countries are taking unprecedented steps to curb the outbreak, with wide-ranging and uncertain repercussions for stability and security around the world. Even as the United Nations has called for an immediate global ceasefire to deal with “the true fight of our lives” (AP, 23 March 2020), some

non-state armed groups like the Islamic State see the crisis as an opportunity to go on the offensive (DW, 23 March 2020).

How will COVID-19 impact trends in global disorder? How will it change the trajectory of conflict and demonstration patterns around the world?

Such a quickly evolving situation requires regular and reliable monitoring. Through the duration of the crisis, ACLED's global network of remote researchers will continue to track these trends in real-time, publishing data on political violence and protest on a weekly basis to support ongoing research, policymaking, and humanitarian efforts. Starting now, ACLED is also launching special coverage of the pandemic's impact on disorder around the world via our new COVID-19 Disorder Tracker (CDT).

The CDT aims to track and evaluate the following expected trends:

- While demonstration activity may initially spike in response to state management of the pandemic, it will soon decline as a function of concern over the spread of the virus, new medical guidelines, and/or government travel and assembly restrictions
- State repression will rise, especially in authoritarian states, under the guise of strict adherence to health security standards
- Mob violence too will rise, with vigilante mobs targeting marginalized groups, such as those suspected of being infected and Asian communities (due to the origin of the virus in China), amid an increase in general xenophobia
- Overall armed conflict rates may remain stable, yet the composition of conflict will change: militaries may decrease their activity as states divert resources to combatting the pandemic. At the same time, non-state actors may look to make 'big moves', especially as some may seize the opportunity presented by the coronavirus crisis to ramp up activity

The pandemic is still in its early stages and we expect trends to continue to evolve, especially in light of the exponential growth that can occur in numbers infected.

About: African countries face varying levels of risk that will require adapting a diversified set of response strategies to the coronavirus. The most vulnerable countries may not be those with the earliest onset.

Much remains unknown about the trajectory of the transmission of COVID-19 in Africa. Many fear that with its high levels of poverty, weak health systems, and crowded urban areas, the virus could be particularly devastating. Others hope that with its warmer climate, youthful population, and experience fighting infectious disease, that Africa will be able to avoid the worst of the pandemic. This analysis provides a review of relative risk factors associated with the novel coronavirus as a means of generating potential insights into the varied and at times overlapping levels of vulnerability faced by each African country.

Mapping Vulnerability by Risk Factor: Understanding the relative risks each country faces can better guide response efforts in both the introductory and subsequent stages as the pandemic evolves. Following are a series of maps graphically representing relative levels of vulnerability across the continent (scaled from 1 to 5, with 5 being greatest level of vulnerability).

Webdebate: In our monthly WebDebate, which is organised in the context of the International Forum on Diplomatic Training (IFDT), we looked at Multilateral diplomacy in times of COVID-19. When we observe the responses to the COVID-19 crisis, we seem to encounter a paradox. On one hand, we have reports that shipments of masks and other key equipment are diverted from their destination countries. On the other hand, there are examples of enormous solidarity within societies and among countries. The work of the United Nations (UN) is clearly important in this crisis. The World Health Organization (WHO) has played a crucial part in responding to the crisis and UN Secretary-General António Guterres called for ‘a global ceasefire in all corners of the world’. He also launched a report on shared responsibility and global solidarity in response to the COVID-19 crisis.

Taking this as a starting point, in this debate we addressed:

- the role of multilateral diplomacy in this crisis;
- the specific role of the UN system and the WHO; and
- the question how the multilateral system and the UN will emerge after the crisis.

Our speakers for this debate were Ambassador Umej Bhatia (Singapore’s permanent representative to the UN Office in Geneva), UN Undersecretary General Fabrizio Hochschild-Drummond (special adviser to the UN Secretary-General on the Preparations for the Commemoration of the United Nations’ 75th Anniversary) and Dr Owain Williams (senior research fellow in global health governance at the University of Leeds).

Webdebate: For many around the world, the briefings of the World Health Organization (WHO) provided crucial information on the emerging crisis. A key moment came when the WHO declared a global pandemic. On March 24th, the UN Secretary-General called for a ‘global ceasefire in all corners of the world’ and argued that ‘the fury of the virus illustrates the folly of war’. Furthermore, responses to COVID-19 illustrate great cooperation and solidarity on the one hand, and evidence of emerging nationalism on the other.

In this WebDebate, we will look at multilateral diplomacy in the times of COVID-19 in three main steps:

First, we will unpack the role of the UN system and the WHO in particular. We will explore how the system is set up to deal with such a crisis and a global pandemic. For example, how does the WHO work with member states, and how is the decision to declare a global pandemic made?

Second, we will branch out to consider the role of multilateral diplomacy more broadly. While there is a general agreement that joined efforts are needed to manage the crisis, responses seem largely unilateral. Some might even say that we are seeing a new nationalism taking hold. Is multilateralism failing us, and if so why? Moreover, is multilateralism failing those most vulnerable to the economic and societal impacts of the corona crisis, namely countries in the Global South?

Lastly, looking ahead, will we see elements of a new UN or a new multilateral system emerge after the crisis, and what will its building blocks be?
